	Convening Notice:
	The Parish Secretary Mrs L Nozedar read the convening notice. An Assembly of the Principals & Electors of the Parish of St Lawrence will be held in the Parish Hall on Monday 10 August 2026 at 7.00pm for the following business: 1. 1.	To receive and if deemed advisable approve the Minutes of the Act of the Parish Assembly held on 23 July 2026.

Mr Winston Le Brun addressed the Assembly, saying that he had great pleasure in proposing Mr Trevor Le Cornu for a further term of office for the role of Vingtenier for the Vingtaine Coin Hatain. He also welcomed Mr Maurant back to the Assembly, having previously stood for the position of Roads Inspector a few years ago. This was seconded by Mr Ian Le Brun. There being no further nominations, the Connétable declared Mr Neil Maurant duly elected. The Connétable thanked him for putting himself forward for the position. The Connétable warned Mr Maurant to appear before the Royal Court on Friday 21 August 2026 at 10am to take the customary Oath of Office.
